Gill Net Permit	\$ 8.00 per each net in use
Haul Seine Permit	\$ 17.50 per each net in use
Eel Pot Permit	\$ 17.50

In addition to the Nonresident Harvester's Permit, the fee for a permit to net nongame fish in Back Bay and its tributaries **FOR SALE** shall be as follows:

Haul Seine Permit	\$ 45.00 per each net in use
Eel Pot Permit	\$ 50.00
